



# Conference on Integrating Sustainable Development and Climate Change

## **Background:**

Achieving sustainable development and managing the climate and bio-diversity crisis require transformative change this decade towards sustainable, equitable, climate resilient, net-zero development pathways in the Global North and the Global South.

Against that backdrop the Conference will facilitate dialogues between Danish and international stakeholders on the benefits of integrating sustainable development and climate change, i.e. on how the sustainable development goals, including poverty reduction, adaptation, mitigation resilience and equitable transition can become mutually supportive.

## Objectives

The Conference dialogues will provide input to:

- A better understanding of the synergies, potentials, benefits, and dilemmas in integrating interventions on sustainable development and climate action.
- A refined methodology on how to integrate sustainable development and climate action,
- Upscaling immediate and simultaneous action across all levels and sectors on sustainable development and climate change,
- A new Danish Afrika Plan; a new Strategy for Development Cooperation and a Strategy for Foreign and Security Policy.
- Danish contributions for the UN Secretary General's 'SDG Summit' and 'Climate Ambition Summit' in 2023 as well as COP28.
- Danish contributions for a partnership with Global South actors on organizing international consultations on integrating sustainable development and climate for the UN Secretary General's 'Summit of the Future' in 2024.

## Context:

The transformative change required must be implemented in a challenging global and geopolitical context:

- The latest IPPC Synthesis Report delivers scientific evidence for the required immediate and simultaneous action across all levels and sectors this decade to ensure sustainable, climate resilient, net-zero, and just and equitable development pathways. It is both necessary to keep the Paris Agreement temperature targets within reach and to avoid undermining the SDSGs because of irreversible negative consequences of climate change to future generations, biodiversity, and the planet.
- The Russian war against Ukraine and increasing geopolitical tensions,
- Polycrisis, defined by interlinkages between uneven post COVID-19 recovery, increasing climate
  and biodiversity crisis, energy and food crises, increased debt in the Global South and the risk of a
  global recession, all of which has implications for security issues and policy,
- Wide-spread mistrust between the Global South and the Global North,
- Need to strengthen rules-based multilateralism to promote global peace and security, defend human rights and international law, and to promote multilateral solutions to global challenges.

- Need for win-win partnerships between the Global South and the Global North, incl both public and private stakeholders,
- Need for massively upscaling investments in sustainable development and climate action, including by innovative finance and domestic as well as international private investments, targeted risk mitigation as well as transparent, stable and predictable framework conditions.
